What is Appraisal and Revalidation?

✓ Revalidation

Revalidation is the process by which licensed doctors demonstrate to the GMC they are up to date and fit to practice

✓ Appraisal

A medical appraisal is an annual meeting – a facilitated selfreview supported by information gathered from doctors' full scope of work

Timeframes for A&R

- ✓ Medical Revalidation Years run from 1st April to 31st March each year
- ✓ An annual appraisal is required within each year
- ✓ The Medical A&R Team will provide an appraisal month upon commencement at the Trust

Doctor Responsibility

- √ To take part in and complete an annual appraisal
- √ Retain a copy of your appraisal documentation post appraisal
- ✓ Summary of appraisal will be required by your new employer if you leave the Trust
- √ To complete a Multi-Source Feedback back once every 5 years

Appraisal Month Allocation

✓ An annual appraisal month is allocated by the Medical A&R Team and is set three months prior to each doctors GMC Revalidation month.

✓ This is to ensure that an annual appraisal is facilitated prior to Doctors GMC revalidation recommendation by the Trust in the 5th year.

Completing an Annual Appraisal

- ✓ A reminder is sent 3 months prior to your annual appraisal month notifying you to organise an appraisal date with your appraiser
- ✓ Reminders are sent until an appraisal meeting date has been provided to the Medical A&R Team
- √The Trust use MYL2P software as a tool to complete Appraisals

Completing an Annual Appraisal

✓ The Medical A&R Team will provide you with an Appraiser for each appraisal year

It is usual to:

- ✓ Have the same appraiser for 3 consecutive years
- ✓ Have an appraiser from a different specialty

To Note:

✓ Both Appraiser and Appraisee need to sign off an appraisal before it is recognised (this is the Appraisee's responsibility)

Multi Source Feedback (MSF)

- ✓ An MSF exercise is a mechanism for colleagues and patients to provide feedback about a practitioners practice
- √ There is 1 MSF cycle per Revalidation cycle
- ✓ 20 returns are required to produce a report from both patient and Colleagues
- √ The exercise is completed via MYL2P

Multi Source Feedback (MSF)

- ✓ The Trust recommend completing this within year 2 or 3 of the practitioner's cycle
- ✓ Reminders are sent automatically from MYL2P
- ✓ Patient feedback is commenced by the practitioner who
 collates colleague feedback and the Medical A&R team
 collate patient feedback on the practitioner's behalf
- ✓ Contact the Medical A&R Team for any support if required

What is feedback is perceived to be negative?

- ✓ Don't worry
- ✓ Feedback should be reflected upon to grow within your practice
- ✓ All feedback is part of development and important
- ✓ Feedback should be uploaded to your annual appraisal for discussion with your appraiser

- ✓ Medical A&R Team can support you and answer any questions or signpost you
- ✓ Meet with your Appraiser ahead of your annual appraisal
