Your request

- 1a) In the 12 months to January 2016 (or to the most recent month available), what was the average waiting time in days (referral to treatment time) for patients awaiting cataract surgery through Blackpool Teaching Hospitals NHS Foundation Trust?
- 1b) In the 12 months to January 2015, what was the average waiting time in days (referral to treatment time) for patients awaiting cataract surgery through Blackpool Teaching Hospitals NHS Foundation Trust?
- 2a) In the last 3 years, how many patients underwent cataract removal surgery at Blackpool Teaching Hospitals NHS Foundation Trust?
- 2b) In each of the last 3 years, how many individual cataract removal procedures were performed at Blackpool Teaching Hospitals NHS Foundation Trust?

- 3d) If yes to 3c, please list the conditions and criteria under which toric intraocular lenses are available to NHS patients.
- 3e) If yes to 3a and/or 3c, how many patients have been fitted with toric intraocular lenses in the last 12 months, for which data is available?
